Mrs. Sargent stated that the event is held for the benefit of Partners in Progress and it is her goal for it to be the largest craft show in Pennsylvania. She is very excited about the event and one of the items is a "golden ticket" that will be in a Highland Chocolate candy bar and the person with the golden ticket must come to the event to see what they have won. She will be advertising within a 55 mile radius of Blossburg.
