

# BLOSSBURG BOROUGH COUNCIL MEETING

## September 12, 2018

Pledge of Allegiance recited.

Council President Jolene Hall called the Blossburg Borough Council regular meeting to order at 6:30 P.M. in the Council Room of the new Borough Building, 241 Main Street, Blossburg, PA.

Recreation Board and Council are to evaluate yearly expenditures that Borough spends to operate Island Park, then take back to STSD to discuss.

Barbeque pit repair materials were ordered and work has begun.

Playground & Tennis Courts: Inspection by Department of Conservation and Natural Resources (DCNR) was done on August 21, 2018. Project passed the inspection.
