Due to the COVID-19 outbreak and the mandatory stay at home Order and distancing Order from the Governor, the Meeting was held via teleconference.

Manager's Report

Mayor: The Mayor reported that the Food Pantry held April 1st was a huge success. A big thank you to Todd Berguson and his driver Jeff Patterson for picking up our multiple loads of food from the Food Bank in Williamsport and bringing them to the Park. The Mayor together with the Supervisors from Bloss Township, Covington Township, Hamilton Township and Putnam Township have joined together to provide the food to those in need. The Food Pantry was a drive-thru system so that individuals did not leave their cars. It worked very well and a total of over 257 families received food from the Pantry.

The Mayor has been in contact with Steve Hall, the Borough's Emergency Coordinator regarding the COVID-19 situation. Based on the Governor's guidelines, it was determined that the Island Park, including ballfields, tennis courts, basketball court, skate park and playground, will be closed to the public until further notice. The walking trail will remain open.

The Ambulance Association has contacted the Mayor regarding the purchase of two (2) monitors, one for each ambulance. The cost per unit is approximately \$3,000.00. The Mayor said that he suggested that the Ambulance Association send a request to the Borough as well as to the Townships that are served by the Ambulance Association detailing the cost, reason for the purchase and request for funds.

Several individuals in the communities are making face masks and have them available for sale. Easter Cards have been made by a few Girl Scouts and will be handed out during the April 10th food pantry.

The Mayor wanted to thank everyone for staying home and taking the virus seriously. It is very admirable that people are doing what is asked. A BIG THANK YOU to all the truck drivers for their deliveries and a to our local businesses for their support and ingenuity. Please support our local businesses during the crisis. Please continue to support our business when you can.

Police: The Chief stated that call volume is low, and the Officers are helping with getting food and other necessities to residents.

The Easter Bunny will be going through town on Saturday, April 11th. There will be NO congregating of individuals.
